# TERMS & CONDITIONS

## Definition:

- “You” – the customer and signee
- “Us” – Ashburton District Council and EA Networks Centre
- “Subscription” – Membership type chosen by customer.
- “Senior” – 65 years and over.
- “Student” – Must provide current full time student ID.
- “Adult” – 19 - 64 years.
- “Child” – 5 - 13 years.
- “Child under 5” – 0 - 4 years.
- “High School” - Student - 14 - 18 years.

## Use of facilities:

- You are entitled to use the facilities dictated by your subscription type during the normal opening hours of the EA Networks Centre which may be changed at any time by us at our discretion. **At times we may close or limit the available facilities due to maintenance, health and safety requirements or for event bookings.**
- You must comply with the rules for the use of the EA Networks Centre facilities.  
You must act with courtesy towards other users at all times.
- The rules may be changed at any time by us at our discretion.
- The rules will be displayed in the facilities and/or our website. A copy of the rules will be available upon request.
- You are required to have your photo taken for identification purposes.

## Registration and Payment

- Places are limited and registrations will be on a first in first served basis
- Upon enrolment it is agreed that all care will be taken with my child in accordance with the EANC holiday programme policies and procedures and I will not hold EANC liable for injury or accident or loss of possessions.
- Payment must be made in full at EANC Reception, prior to the program starting to secure your child's spot.

## Health and Safety

- Caregivers are required to complete the EANC PAR-Q form to disclose any health related information.
- Your child's health on arrival is your responsibility. If you have any questions or concerns about your child's health when exercising you should see your doctor before they attend the Holiday Programme.
- Your child's safety is your responsibility. If you have any prior questions or concerns about your child exercising safely you should see your doctor.
- We will comply with our obligations under health and safety legislation.
- To assist us to maintain the equipment in a safe condition, please advise of anything you observe which needs our attention.
- Your child is expected to comply with all instructions from our staff.
- Recreational activities at any level carry an inherent risk of physical injury. The EANC Staff will take all reasonable measures to avoid any possible injury to any participant.
- All participants, visitors, invitees, attendees and others who are involved in the EANC Holiday Programme take part in the activities at their own risk and shall hold harmless and indemnify the EANC staff and associates, from and against any and all liability of whatsoever nature.
- The EANC Staff do not accept any obligation, responsibility, liability for
  1. Loss, theft or damage to or of any personal belongings whatsoever.
  2. Loss, accident, illness, injury, death to or of any player, participant, visitor, invitee, attendee or other person at the EANC Holiday Programme.
  3. Any matter or thing beyond control.
- EANC Staff may seek medical attention for any participant if it is required. A trained first-aider will be available at EANC.

## Behaviour

- EANC programs are about participation and fair play. By entering, you and your child agree to abide by the principles of Fair Play (i.e. respect the rules, courtesy for others, just and equitable treatment for all participants, spectators and volunteers alike).
- Any bullying or disruptive behaviour will not be tolerated, and the EANC staff reserve the right to exclude any participant whose behaviour is deemed to be detrimental to the program or other participants. Should this occur, the parent/guardian named on the registration form will be contacted and they will be required to immediately remove the participant.
- As a caregiver I understand that for health and safety reasons, participants (i.e. my child) must; abide by all directions given by instructors/EANC Staff non-compliance may result in the participant being excluded from activities in the EANC holiday program.

## Gear to Bring

- Your child must be dressed appropriately with appropriate footwear (no singlets, jeans or jandals).
- Wet weather gear if raining.
- Children must have their **own drink bottle, morning tea snack and lunch each day** (unless the subway option has been selected on the available day).
- Togs and towel on indicated days.

## Cancellation

- Should a caregiver wish to cancel their child/s place in the program, they may do so if the absence is notified to EANC reception (03 3084020) at least 48 hours prior to the EANC Holiday Program's commencement date.
- A refund may be provided for sickness of your child, given proof of a medical certificate relevant to the holiday programme day missed.
- EANC reserves the right to cancel a programme at any time. If a programme is cancelled a full refund will be provided.

## Liability

- All participants, visitors, invitees, attendees and others who are involved in the EANC Holiday Programme take part in the activities at their own risk and shall hold harmless and indemnify the EANC staff and associates, from and against any and all liability of whatsoever nature.
- The EANC Staff do not accept any obligation, responsibility, liability for
  1. Loss, theft or damage to or of any personal belongings whatsoever.
  2. Loss, accident, illness, injury, death to or of any player, participant, visitor, invitee, attendee or other person at the EANC Holiday Programme.
  3. Any matter or thing beyond control.
- We will comply with our obligations under the Consumer Guarantees Act 1993.
- Except as provided by statute, we are not responsible for any injury you may suffer during or after exercising on our premises.
- We are not liable in contract or tort or otherwise except as provided by the Consumer Guarantees Act for the damage to or loss of your personal property.

## Privacy

- Personal information about you/your child/children on your subscription form will be used and held by us for administration of your subscription. This includes notifying you of any changes at the facilities, any changes to these terms and conditions, and any other services available to you as a member.
- In accordance with the Privacy Act, you are entitled to access and correct the personal information held about you.
- Unless you opt out your/your child's information and photo may be used by us for marketing purposes. Your/your child's photo will be taken upon issue of membership or concession card.

## Late Fees

- I agree that if I fail to collect my child between the allocated times listed above, I will be charged a late fee of \$20 per child.
